CHANGES IN CONSTITUTION AND BY-LAWS

The number of returns on the changes in the Constitution and By-Laws, delineated in the December 31, 1957 Newsletter, was short of the number required to effect action. Of the 94 ballots received, 93 were in favor of the changes proposed. However, with an official membership of 806, a minimum of 20% or 171 returns are required for adoption.

At the March 26 meeting of the Administrative Committee the Amendments and the changes in the Constitution, with minor modifications, were unanimously approved.

For final adoption, it is now necessary to re-submit to the membership the proposed changes in the Constitution dealing with the procedure for future amendments and election to the Administrative Committee.

This will be submitted for vote to the membership after approval by the IRE Professional Groups Committee and the IRE Executive Committee.

We urge you to vote and return the ballot as soon as possible after you receive it.
